UKC Judges and Handlers Seminar

Presenter: UKC Judge Instructor Peter Wax

Who Should Attend: Judges, Apprentice Judges, Those considering becoming a UKC Judge, and

Those who want a more complete understanding of UKC Field Trial Rules.

The seminar includes a presentation on the UKC Pointing Dog Rules for Field Trials, TAN, and WRT. Each participant will have the opportunity to receive a judge's test and submit successfully completed test to UKC. Rulebooks will be provided. If time permits, discussion and analysis of field events with dogs will move outdoors.

About the Presenter: Peter Wax has been hunting and training versatile hunting dogs for 46 years, testing dogs in the NAVHDA venue for more than 20 years, trialing in the UKC Pointing Dog Program for 15 years, and judging UKC field trails for 11 years. Peter was the first handler to ever place a dog "First" in a UKC Open Wild Trial and since then has trained and handled his personal dogs to a pass or placement 17 times including two firsts at Club Epagneul Breton National events for a placement/run average of well over 50 percent. Peter's background of 50 years a hunter and trainer and



years as a handler in UKC and NAVHDA events brings a knowledge earned in the school of hard knocks and a vison polished by experience.

### 2:30 – How to Get Your Dog Out of a Trap with Terry Jacobson

Take an hour to save your dogs life. Terry will be sharing his extensive knowledge of dogs and trapping and will show you proper techniques for releasing dogs from traps as well as what to look for or common areas that traps are set. This will be a hands on demonstration allowing you to learn how to work foot hold, body grip and snare traps and what tools you should have with you in the field if your dog should ever find itself in a trap. Terry has been around dogs and traps since he was 8 years old and has trapped in Wisconsin and South Dakota.

#### 2:30 -- Grouse and Woodcock 101 with Terry Petro

Terry Petro got his first "real" hunting dog in 1980 and immediately got sucked into training and testing in the NAVHDA world. In 1981 he became an Apprentice Judge in the NAVHDA system, was certified as a judge in 1986 and became a senior judge in 1990. He started guiding as a Hunstman for the National Grouse and Woodcock hunt, sponsored by the Ruffed Grouse Society, in 1984 and would have had streak of 36 straight years until this past year when the event was cancelled because of Covid. From there he and his Drahthaars have been guiding at Pineridge Grouse Camp since 2012.

Terry has applied his hunting skills in the spring banding woodcock since 1992. Terry and his brother Chris are 2 of the original 6 Banders in the modern banding program here in Minnesota. Since his retirement in 2008 he has been representing Purina at various canine and outdoor events as well as traveling the country with his dogs and his shotgun. Terry will be discussing grouse and

woodcock habitat, hunting techniques, specific dog training methods, as well as his experiences as a quide and woodcock bander


